Information on the transfer of part of open pension funds' assets to Social Insurance Institution

Ministry of Finance informs that according to the article 23 of the act from December 6, 2013 on the changes of certain acts that are setting principles of pension benefits' payments from contributions gathered in Open Pension Funds (OPFs), on February 3, 2014 OPFs transferred to Social Insurance Institution (ZUS) securities in the total face value of PLN 153,151.2 million, of which:

- PLN 130,187.6 million were Treasury securities,
- PLN 15,614.2 million were bonds issued by Bank Gospodarstwa Krajowego according to the principles set forth in the act from October 27, 1994 on toll roads and the National Road Fund, guaranteed by the State Treasury,
- PLN 252.5 million were other securities guaranteed by the State Treasury.

OPFs transferred also to ZUS cash in the amount of PLN 1,862.2 million.

According to the act, Treasury securities are acquired by State Treasury and then cancelled. Remaining assets are subject to transfer to the Demographic Reserve Fund.

The cancellation of Treasury securities acquired by the Minister of Finance, who represents State Treasury, from the ZUS results in reduction of the face value of State Treasury debt by PLN 130,187.6 million (GDP 7.6%) and decrease of the general government debt (EU definition) by PLN 145,801.7 million (GDP 8.5%).

Taking into account both the impact of the transfer of the part of OPFs' assets to ZUS and other changes in the pension system (including voluntary mechanism and gradual transfer of assets of the insured with 10 years or less to the retirement age), changes in the pension system will result in reduction of public debt by more than 8% of GDP and of general government debt (EU methodology) by more than 9% of GDP.
