Government Plenipotentiary for Euro Adoption in Poland


- Appointed in January 2009 by a Government Decree
- Secretary of State in the Ministry of Finance
- Responsible, among others, for:
 - Initiating, coordinating and monitoring euro changeover preparations in public administration
 - Informing Prime Minister about any delays and threats to the timely fulfillment of tasks related to euro adoption
- Supported by a 6-person team (the Bureau of Government Plenipotentiary)



Organisational structure for euro adoption in Poland

- Established by a government decree in November 2009
- ➤ Main tasks:
 - Developing policy measures to maximize benefits and opportunities while minimizing costs and threats

Monitoring Poland's readiness to fulfill the convergence criteria on a lasting basis

Organisational structure for euro adoption in Poland

- Ca. 150 people
- > Level:
 - ➤ Secretary/Undersecretary of State/Chair persons/Presidents (strategic level)
 - ➤ Undersecretary of State/Directors (coordinating level)
- Over 30 institutions involved mostly public administration
- > Benefiting from the experiences of other countries
 - ➤ Additional Working Committee for Macroeconomic Issues, in order to monitor sustainability of economic convergence


Practical preparations in Poland (1)

- ➤ April 2010: detailed schedules for the Working Committees (published on the euro-website), including tasks to be completed throughout the whole preparation process
- October 2010: Strategic Guidelines for National Euro Changeover Plan

➤ December 2010: Analyses of the experiences of EU member states (prepared by each Working Committee)

Practical preparations in Poland (2)

- March 2011: International Conference on Euro Changeover Preparations
- > 2Q2011: Twinning programme
- ➤ 3Q2011: Preparing the National Euro Changeover Plan
 - ➤ Based on inputs from Working Committees
 - > Bulgaria, Poland, Romania, Sweden so far without NECP
 - ➤ Poland: Big country big challenges

Having finger on the pulse of the organisational structure

- > Regular reporting (every 6 months):
 - ➤ Working committees → to the Council
 - ➤ Council → to the Plenipotentiary
 - ➤ The Plenipotentiary → to the Council of Ministers
- Plenipotentiary's representatives participating in all the Working Committees' meetings
- > "Reminders"
 - Additional disciplining tool requested by the National Committee
 - > Launched each time a deadline has not been met
 - ➤ The Bureau's job






Challenges now and ahead

- ➤ No target date motivation challenge
- > Big-NMS challenges
 - ➤ Cash changeover Big-bang feasibility
 - ➤ Information campaign
 - > Consumer protection
 - > Public administration
- > Political agreement on euro adoption
- Shifting public opinion (esp. during the recent turbulent times)






Latecomer: benefits or costs?
